COMPETITIVE EXAMINATION (CSS)-2008

Further to FPSC's public notices published on 06-05-2007 and 30-09-2007, it is notified that the Federal Public Service Commission will hold the Competitive Examination 2008 for recruitment to posts in BS-17 in various groups/services under the Federal Government with effect from **Saturday 15th March, 2008** simultaneously at 17 different places in Pakistan.

ELIGIBILITY: Both male and female candidates including disabled persons having at least 2nd Class Bachelor's Degree and within 21-28 years age on 1st Jan, 2008 will be eligible for this examination. The upper age limit will be relaxed by two years upto age of 30 years as per rules provided with the application form.

VACANCIES: 1. The number of vacancies to be filled on the basis of 2008 Examination, will be announced later. 2. **The candidates of AJK State subjects** will also be considered for the **05** posts of Assistant Commissioner Income Tax-cum-Assistant Collector CE&ST/Excise and Taxation Officer in BS-17 in the Income Tax department, under the Azad Jammu and Kashmir Council Secretariat, as per rules.
